1ST QUARTER REPORT (PERIOD JANUARY 2022 TO MARCH 2022)

<u>Article 17 — Law 3269</u>

Through the enactment of Law 3269, the Provincial Legislative Power created the Fund for the Stabilization and Development of Neuquén (Fondo de Estabilización y Desarrollo del Neuquén, FEDeN) as a fiscal policy tool to promote sustainable development in the Province, under the legal form of a trust. The purpose of this report is to comply with the provisions of Article 17, Subsection b, where it is established as a duty of the trustee "To disclose, in compliance with the principles of transparency and publicity, the information relevant to the management of the funds created by this law, on web pages or alternative means that ensure public access, which must be presented quarterly in Spanish and in English"...

Relevant events prior to the start of the quarter:

On December 30, 2021, the Regulation of Law 3269 was approved by means of DECTO-2021-2295-E-NEU-GPN, processed by EX-2021-01544959-NEU-MEI. Article 3 of this regulation designates the Ministry of Economy and Infrastructure, or the Ministry that may replace it in the future, as the Authority of Application of the Regime established by Law 3269.

Main actions of the quarter:

- On February 9, 2022, through DECTO-2022-233-E-NEU-GPN, the Trust Agreement called "Fund for the Stabilization and Development of Neuquén" to be signed by the Province of Neuquén, in its capacity as Trustor and Fiduciaria Neuquina S.A., in its capacity as Trustee was approved. In turn, Art. 3 determines that the representative of the Board of Directors who will accompany the Chief of the cabinet of Ministers and the Minister of Economy and Infrastructure—both designated by Law 3269, Art. 16, Subsection f)—will be the Secretary of Planning and Action for Development (COPADE).
- On February 10, 2022, the above-mentioned Contract was signed, which becomes part of EE 2022-00024194- -NEU-MEI in its order 26, through IF 202200024194- -NEU-MEI dated February 16 of the current year.
- As from the execution of the Trust Agreement and as required by Art. 17, Subsection a) of the Law, the registration tasks with the corresponding agencies began. On the one hand, registration with the Federal Agency of Public Revenues (Agencia Federal de Ingresos Públicos, AFIP) was completed and Taxpayer ID No. 30-

30-71749093-9 was generated. Also, registration with the Provincial Revenue Office (Dirección Provincial de Rentas, DPR) was completed. Both procedures were completed on February 23 of the current year.

- Once the preceding procedures were concluded, the actions were initiated before the Banco Provincia de Neuquén S.A. (BPN) to open the current account of the Trust Fund, which was authorized on March 11 of the current year, under number 969853/1. This account will be the operating current account for the accreditation of the fiduciary contributions that the General Treasury of the Province will make, as established in Provincial Law 3269.
- On March 17 of the current year, by means of NO-2022-00453784-NEU-FIDUCIARIANQN, the Honorable Legislature of the Province of Neuquén is required to inform the designation of the three representatives of the Legislature of Neuquén who will form part of this decisionmaking body, in accordance with the composition of the Board of Directors provided for in Article 16, Subsection F of the aforementioned Law.
- On March 22 of this year, Fiduciaria Neuquina S.A. and Banco Provincia del Neuquen, in their respective capacities as Trustee and Financial Agent of FEDeN, signed a document with the aim of establishing operating guidelines and regulating the relationship between the two insofar as to this Fund.
- Through NO-2022-00549823-NEU-SEMH#MERN, the Ministry of Energy and Natural Resources, through the Undersecretary of Energy, Mining and Hydrocarbons and in compliance with the provisions of Provincial Law 3269, certifies that for hydrocarbon production for the month of January 2022, the conditions set forth in subsections a) and b) of Article 2, Chapter I, of Law 3269 are met, thus the establishment of the Fund for the Stabilization and Development of Neuquén is due.
- On March 31 of the current year, and in accordance with the information detailed in the preceding paragraph, Fiduciaria Neuquina sent note NO-2022-00556324-NEU-FIDUCIARIANQN to the General Treasury of the Province, indicating to make the corresponding transfer to the current account of the Fund, for its allocation to the Anticyclical Sub Fund.

Relevant events after the end of the quarter:

- Through a Note dated April 12 of the current year, the Secretary of the Chamber of the Honorable Legislature of Neuquén, informs the members of the Board of Directors of the "Fund for the Stabilization and Development of Neuquén" according to the appointments made by the presidencies of each Political Block. In this sense, it is indicated that for the Movimiento Popular Neuquino Political Block, Mario Pilatti is designated as full representative, and Ms. Liliana Murisi is designated as alternate representative; for the Frente de Todos Political Block, Mr. Osvaldo Darío Peralta is designated as full representative;



while for the Juntos por el Cambio Political Block, Mr. Pablo Emilio Guido is appointed as the main representative and Mr. Juan Manuel Morales as the alternate representative.

It should be noted that, in parallel with the development of the previously detailed facts, working meetings were held with representatives of the Financial Agent of the trust fund (Banco Provincia de Neuquén S.A., designated by Law 3269 Art. 16, Subsection e), where the progress in the preparation of the Investment Policy. The Institution should submit this Policy for its approval by the Board of Directors, as stipulated by Art. 19 of the aforementioned regulation.

- Note NO-2022-00556324-NEU-FIDUCIARIANQN to the General Treasury of the Province, indicating to make the corresponding transfer to the current account of the Fund, for its allocation to the Anticyclical Sub Fund.
